## Message from the President

On August 26<sup>th</sup> we celebrated the 90th anniversary of the ratification of the 19th Amendment recognizing the American woman's right to vote. In four generations we progressed from disenfranchisement to the first viable female presidential candidate – and it all started at the ballot box.

We've already begun to hear the predictable complaints that our votes don't really count or don't affect the outcome anyhow, and that voting merely legitimizes a corrupt political process.

So let me tell you why I believe voting is important, and it's not about complaining or doing your

"duty." Voting is about honoring the principles and ideals on which our nation was founded by participating in the democratic process.

In America you are free to choose not to vote, but in so doing you dismiss the sacrifice of blood and treasure made by every generation since 1776 to ensure your right to live in a free country. You also dismiss the future by ceding influence to special interests, by ignoring your opportunity to make your community and the world a better place, and by setting a poor example for the next generation.

I thank each one of you for being a part of a better future for all of us.

## Fair Districts for Florida in 2010

Florida is a politically balanced state, because the number of registered Republicans and Democrats is roughly equal, with a healthy dose of Independents thrown in. That's why Florida is a key battleground state in every national election. Unfortunately, our government and legislature is any **but** balanced, thanks to decades of gerrymandering by Tallahassee.

Today we have illogically-shaped districts with voters who often do not share common needs or objectives. As a result voters are less likely to connect with elected officials; have few choices or competitive races; and are less likely to vote when the result is preordained. Incumbents from both parties benefit and are to blame, but this year Florida voters have an opportunity to change all that, thanks to Amendments 5 and 6.

Florida legislators adjust the state's Congressional and Legislative districts every 10 years after the census, and the present system allows them to draw districts for their own political advantage. The Fair Districts amendments will

challenged, and the Florida Supreme Court upheld lower court rulings, so those amendments won't appear on the ballot.

**Be an informed voter:** Don't wait until Election Day to find out about the proposed amendments and how they will affect our state and our community.

provide standards that prohibit this practice while adhering to federal guidelines, protecting minority voters, and promoting compact and contiguous districts drawn along existing political and geographic boundaries where possible.

The League has been involved in redistricting reform efforts since 1968, including multiple citizen initiatives and Constitutional revision attempts. In response to 2010's successful citizen initiative, the Legislature passed a "poison pill" amendment on the last day of the session in an attempt to negate Amendments 5 and 6 and retain their absolute control of the redistricting process.

Fortunately Florida's District and Supreme Courts rejected both the Legislature's proposed Amendment 7 as well as their legal challenge to Amendments 5 and 6. Voters now have a clear choice in November.

Florida's future is in your hands: *Don't let Tallahassee politicians maintain the status quo.*
