**Immigration Consensus**

Thanks to all the members who participated in the consensus meeting on January 5th. There were many complex issues to consider, but we did find common ground.

Members generally believe legal immigration is a net plus for the US, but illegal entry makes unauthorized immigrants vulnerable to exploitation, is unfair to legal immigrants, may drive wages down for citizens, and creates a burden on local governments and infrastructure.

Unauthorized immigration must be brought under control by simplifying immigration law, approving immigration for nuclear families (spouse and unmarried dependent children) as a whole, and matching immigration quotas to

business/economic requirements.

US sovereignty and national security must be reinforced, not undermined, by immigration policy. We should also tailor our foreign policy to help other nations redress the economic disparities that make the US so much more attractive than “home.”

The US League will tabulate responses from all the local Leagues to determine if consensus has been reached and a position can be adopted. The final report will be published next fall.

The consensus process helps set the agenda for League’s lobbying efforts, so thanks again to all who made a difference on January 5<sup>th</sup>.

**Why aren’t more American women in Politics?**

After the overthrow of the Taliban in Afghanistan and Saddam Hussein in Iraq, the United States made sure that when those two countries held elections, 25% of the seats in their legislatures would be reserved for women. That may not seem like much, but it’s better than the current US Congress, where women account for just 16.3% of members (16 of 100 in the Senate; 71 of 435 in the House). Eighty-four other nations have a greater percentage of female legislators than the US, including Mexico, Canada, Rwanda, Vietnam and Cuba.

According to the Eagleton Institute of Politics at Rutgers University, of the current members of Congress and the nation’s governors, 86% are men, 81% are white, and 29% have a relative who served in office. Marie Wilson, president of The White House Project, a nonparti-

san organization that seeks to get more women in leadership roles, says the media don’t take women politicians seriously. She cites a White House Project study: on Meet the Press and other TV talk shows, which often shape policy, male guests outnumbered women 13 to 1 after 9/11, though Dianne Feinstein and two other women chaired Senate subcommittees on terrorism.

For this year and beyond, The White House Project is launching “Vote, Run, Lead,” to get more women into the voting booth and into public office. “We must interest young people in the value and meaning of voting and politics,” says Wilson. And that is no easy task: It takes at least six requests to get a new voter to the polls. Visit [www.voterunlead.org](http://www.voterunlead.org) to learn more.

## January Hot Topic: Property Tax Amendment

A standing-room-only crowd filled the Shalimar Town Hall on January 12th to learn about Amendment #1 and how it will affect them and Okaloosa County.

County Property Appraiser Pete Smith opened the panel discussion by stressing that Amendment #1 is not tax reform, but will provide some tax relief. He assured the audience that the Save Our Homes cap on tax increases would remain in place, though it has only been invoked in 3 of the last 15 years. The amendment requires 60% voter approval to pass, and homestead property owners can expect an average savings of \$240 a year if it does. Homestead owners may also take their exemption with them if they move, but a number of restrictions apply.

County Commissioner Sherry Campbell assured the audience that she and her colleagues were good stewards of public funds. County millage rates decreased each year for the last 3, and were flat for 3 years before that. She warned attendees to consider what they will be giving up for the estimated \$20/month savings, since the county has \$1B in unfunded mandates from State and Federal levels, and \$1.43B in mandated revenue cuts. The Commission reserved \$1M from increased revenues in 2004-07 to cover the cost of future infrastructure projects. However, reserve funds are reported as income, turning the commission's careful planning into a "\$1M budget increase."

## Legislative Forum in Sandestin

On January 17th local area Chambers of Commerce sponsored a public forum for the northwest Florida state legislative delegation featuring Senators Don Gaetz and Al Lawson Jr., as well as Representatives Ray Sansom, Don Brown, Marti Coley, Greg Evers, Dave Murzin and Jimmy Patronis.

Panel members fielded questions on small business concerns, transportation infrastructure, illegal immigration and tax reform, among others.

Panel members sympathized with local governments, which they said had done a good job of not abusing taxpayers, even

Fort Walton Beach Mayor Mike Anderson provided details on the city budget and enjoined citizens to come to planning meetings and provide feedback to the City Council. He noted that the city has been cutting staff since 2000 and is actively pursuing more budget savings. The city has also received its share of unfunded mandates as ~\$4.1B in school, pension and insurance costs has been rolled down to the local level. The cost of doing business is going up, and cities need some breathing room to absorb growth-related issues, but instead of providing a comprehensive plan, the state offers band-aids for "feel good" issues.

When asked to name what would be cut if Amendment #1 passes, Commissioner Campbell said capital improvement projects would be delayed. Mayor Anderson said 14 projects were at risk, but the final decision was up to the City Council.

Mr. Smith explained that tax law is in the state constitution, so an amendment is required change it. He also noted that an *ad valorem* sales tax is a potential alternative to property tax **only** if appropriate reserves are kept, and it would still be "very volatile." Instead he recommended reducing the rate at which property assessments are made.

during the real estate boom. Mr. Sansom said the legislature was forced to address property taxes due to local inaction. Amendment #1's "one size fits all" tax relief resulted. Ms. Coley urged attendees to "rethink" how they want government services provided, as government is all about its own prosperity, not that of taxpayers.

Mr. Sansom closed by praising the CoCs for jointly sponsoring the forum, and vowed that the NW Florida legislative delegation would also work together to ensure our area's interests are protected during upcoming budget debates.

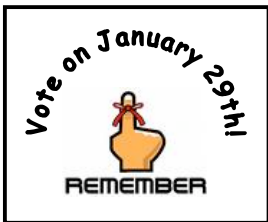
